

TRANSFER STUDENT ACADEMIC SCHOLARSHIPS

Students who have attended previous colleges or universities may be eligible for an academic scholarship based upon their combined cumulative GPA as follows:

3.5 to 4.0	Presidential Transfer	\$15,000	3.0

- PHI THETA KAPPA SCHOLARSHIP In addition to the academic scholarship, Phi Theta Kappa members can earn an additional \$2,000 annual scholarship. Renewable with a 3.0 LU GPA.
- ULRICH SCHOLARS Ten renewable scholarships of \$20,000 are available for new students eager to explore the intersection of faith, reason, and justice. Students must declare and maintain satisfactory academic progress towards a minor or major in religion and participate in programing of the Ulrich Center for Philosophy, Ethics, and Christian Thought. Priority application deadline of Jan. 16, 2022.
- COL. YONG CHUE YANG SCHOLARSHIP Student descendants of families who were displaced by the Vietnam Conflict are eligible to apply for the renewable \$15,000 Col. Yong Chue Yang Scholarship. This scholarship cannot be combined with any academic scholarships. Open to new, full-time freshmen or transfer students. Application deadline of July 1, 2022.

PARTICIPATION SCHOLARSHIPS

- **THEATRE SCHOLARSHIP** Awards \$1,000 \$3,000 per year to qualified theatre performers and production assistants. Open to new, full-time freshman or transfer students. Audition required, along with participation in Lakeland's productions. Renewable. **Application deadline of July 1, 2022.**
- ANDRÁS VISKI PIANO SCHOLARSHIP Awards \$1,000-3,000 per year to an accomplished piano student who serves as accompanist to choral students. Audition required for initial award. Renewable upon audition each year. Priority application deadline for top awards is Feb. 1, 2022. Rolling application deadline for remaining awards is May 1, 2022. Auditions scheduled upon completion of application.
- HELEN BOATWRIGHT MUSIC SCHOLARSHIP Awards \$1,000 \$3,000 per year to qualified music students. Annual audition required, along with participation in a band or choral group at Lakeland. Open to new, full-time freshmen or transfer students. Renewable. Priority application deadline for top awards is Feb. 1, 2022. Rolling application deadline for remaining awards is May 1, 2022. Auditions scheduled upon completion of application.
- **ESPORTS SCHOLARSHIP** Awards \$1,000 \$3,000 per year to qualified eSports student athletes. Open to new, full-time freshman or transfer students. eSports Head Coach may recommend scholarship amounts by observing try-outs, reviews of film, combines, tournaments, or season matchplay, as well as in-person or virtual campus visits. Renewable. Priority award deadline of May 1, 2022.

Combined Lakeland scholarships should not exceed \$21,000 (excluding full-tuition scholarships).

GRANTS & LOANS

INSTITUTIONAL GRANTS

Lakeland University awards need-based institutional grant funding to help families manage the cost of continued education. Determination of Lakeland grant funds is based upon the results of the FAFSA and the student's application for admission.

LAKELAND PROMISE

The Lakeland Promise will provide qualified Wisconsin students an opportunity to attend Lakeland tuition/fees free for four years, up to three years for transfer students. Lakeland is Wisconsin's first private college to offer a free tuition promise program for qualified students.

- Federal Work Study Not a grant or loan. Funds must be earned by working a parttime campus position. Funds are paid directly to students based on hourly earned wages via a bi-monthly paycheck.
