The absence of health insurance coverage does not make Lakeland College or Lakeland College Music Camp responsible for payment of medical expenses.

The agency providing liability coverage for Lakeland College REQUIRES you to sign the following Waiver and Release. Your cooperation is greatly appreciated. Please read this form carefully and be aware that in registering your minor child/ward for participation in the Lakeland College Music Camp, you will be waiving and releasing all claims for injuries your child/ward might sustain arising out of these programs.

Release of Claims

As a participant in the Lakeland College Music Camp, I agree to assume full risk of any injuries, including death, damages or loss regardless of severity, which my child/ward may sustain as a result of participating in any and all activities connected with or associated with the camp. I agree to waive and relinquish all claims I or my child/ward may have as a result of participating in the Camp against Lakeland College and its directors, officers, trustees, agents, servants and employees.

I do hereby fully release and discharge Lakeland College and the Lakeland College Music Camp, and their respective directors, officers, trustees, agents, servants and employees from any and all claims from injuries, including death, damage or loss which I or my child/ward may have or which may accrue to me on account of my participation.

I further agree to indemnify and hold harmless and defend Lakeland College, the Lakeland College Music Camp and their directors, officers, trustees, agents, servants and employees from any and all claims from injuries, including death, damages and losses sustained by me or my child/ward or arising out of, connected with, or in any way associated with the activities of the program. I do hereby fully release and discharge Lakeland College and the Lakeland College Music Camp, and their respective directors, officers, trustees, agents, servants and employees from any and all claims resulting from loss or damage of personal property.

Permission to Secure Treatment

In the event of an emergency, I authorize Lakeland College officials and/or Lakeland College Music Camp officials to secure treatment (from licensed hospital, physician, and/or medical personnel) necessary for my child's/ward's care and I will be responsible for payment of any and all medical services required.

Photo Policy

All participants agree that any photography taken while participating in Lakeland College Music Camp may be used for promotional purposes for the Lakeland College or the Lakeland College Music Camp.
